FACTS	WHAT DOES COMMUNITY BANK DO WITH YOUR PERSONAL INFORMATION?
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: • Social Security number and Transaction or loss history • Account balances and Overdraft history • Payment history and Account transactions
	When you are <i>no longer</i> a customer, we continue to share your information as described in this notice.
How?	All financial companies need to share their customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Community Bank chooses to share; and whether you can limit this sharing.

What we do	
How does Community Bank protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We also maintain other physical, electronic & procedural safeguards to protect this information and we limit access to information.
How does Community Bank collect my personal information?	 We collect your personal information, for example, when you Open any type of account or apply for a loan Deposit money or use your debt card Give us contact information Show your government issued I.D. We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.
Why can't I limit all sharing?	 Federal law gives you the right to limit only Sharing for affiliates' everyday business purposes—information about your creditworthiness Affiliates from using your information to market to you Sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing.

Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies • Community Bank has no affiliates.
Nonaffiliates	 Companies not related by common ownership or control. They can be financial and nonfinancial companies. Community Bank does not share with non affiliates so they can market you.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. • Our joint marketing partners: Securities or Investment Dealers, Insurance, Indentity Protection & Restoration & Card Providers.
